The current statements are satisfactory. The Council discussed the urgent need to respond to CCBC by 1 Feb on its proposed setting of the Band D Council Tax rate for 2017/2018. The Council agreed to raise the Band D figure from £17.50 to £18.10 in line with its three year business plan/budget. The Council agreed that its two major contracts for 17/18 for the summer flower baskets and the Festive Lighting ought to be again awarded to Greenleif providing both costs are in line with the recommended OVW financial regulations guidelines. The Clerk is to investigate the contract amounts in the guidelines and report back to the Council. The Clerk reported that the Council must advise the Pension Regulator of its employee status via the NEST pension scheme by 1 July 2017
