612 Chair's and County Members' updates

The Chair, Cllr Tony Davies, reported on the poor health of Cllr Brian Hancock and the Council wished him well for a speedy recovery. He added that he had recently visited Risca Scouts and met with the local representative of the SHADE charity. County Cllr Bob Owen reported that the new community garden project is ongoing and that he had permission for early clearance work to commence from the landowner. He confirmed that the stonework from the Brooklands Road site is to be stored for the garden's future use and that he was progressing work for a Coal Dram near Crescent Road. Cllrs Owen and Whiting both confirmed that Caerphilly Council's plans for a bar to be part of the Risca Summer Fayre had been cancelled. Cllr Owen presented an invoice for electrical sockets for the marquee

The Council noted their disappointment at the recent Report from CCBC to the Boundary Commission that it had recommended that Fernlea and its adjacent area ought to be transferred to Risca East from Risca Town, without any consultation with the residents affected
