273.1 Notice Boards

The Clerk and Cllr Hancock to pursue a replacement public board on the Well chemist shop frontage with a local builder

273.2 Finance Report

The current statements are satisfactory. Following advice from OVW, Council agreed to raise the previously agreed amount for this year's transfer of funds to the Elections/reserves account from £1500 to £3000. Following the success of the Queen's Birthday Beacon with the Twmbarlwm Society, Council agreed to donate a further £100 to the Society. Gwyn James, Clerk of Risca East Community Council has confirmed his appointment to carry out the Town Council's Internal Audit for 2015/16 in readiness for the Annual Return for July. At the AGM the Council agreed to raise the Clerk's average weekly hours from 12 to 20 hours per week

273.4 Correspondence/financial assistance applications

Pontymister FC to be asked to submit an application form. The Risca Girl Guides are also to submit a form and Council agreed to set aside a maximum amount of £600 for the Guides transport. The Council were unable to support an application from the Salvation Army. CCBC had asked for the Council's view on introducing a new 'no cold calling zone' in Tan y Bryn. Clerk to advise CCBC that the Council supported the request. Risca Cap Centre had emailed Cllr Brian Hancock for assistance – Council wish to see written papers from the Cap Centre to consider. CCBC Parks had quoted a summer Sunday toilet block opening fee of £46.14 for each Sunday. Risca East had agreed to jointly fund this summer project with the Town Council. The Clerk is to enter an agreement with Parks to pay for the toilet block to be open to the public on Sundays from 12 June to 28 August 2016. CCBC had asked for application forms to be submitted to take part in their Summer Fayre on 9 July. Council agreed to consider a jointly funded larger marquee for 2016 with a catering provision for 'afternoon tea'

The contract work of flowers in hanging baskets in the summer, to be funded by the Town Council, are expected in the Town in early June (exact date is dependent on the weather conditions)
