758 Presentations

Risca Town resident Mrs Ffion Green was introduced to the Council as an applicant for the Member Vacancy for the Risca Pontymister Lower Ward. The vacancy has existed since May 2019. Ffion has been the Town Council's nominated representative on the Risca Primary School's board of governors since 2013 and she is the current Chair of that Board of Governors. The Council unanimously agreed to co-opt Ffion onto the Council as the Member to represent the Pontymister Lower Ward in time for its next Council meeting on Mon 11 January 2021. The clerk is to inform the Electoral Services Officer at Caerphilly county borough council of the agreed co-option

The meeting acknowledged that the agreed minutes were signed as a true and correct record. The Clerk will arrange for the December meeting minutes to be exchanged by post for signature as soon as practically possible

762 Chair's and County Members' updates

The Chair confirmed that the Council had transferred £5000 from the Town's main account to the Risca C-19 Volunteers Group account. The Volunteers Group were assisting Risca residents who were in need during the current health crisis

763 Clerk's Report

763.1 Finance Report

The Clerk reported that he still had not received the 19/20 annual return for Audit Wales from their nominated external auditor and that the half year internal audit for this year had been completed by exchange of emails only. The monthly account summary to date was agreed as satisfactory by the Council. The Clerk reported that he was awaiting written confirmation from HSBC Bank to transfer the amount of £365 in the Chairperson's account (that we can no longer access) to the main HSBC account. The Clerk presented a budget report for 2021/2022 for the Council's consideration and decision. The budget included a slight increase in expected expenditure across a few headings to take into account prices inflation and an anticipated services increase on the Projects for next financial year. This showed an increase of the annual Band D household rate from this year's figure of £26.50 to £27.70. The Council agreed to the £1.20 rate increase for 2021/2022

763.2 One Voice Wales/CCBC/WG/SLCC/TCCLC

The Clerk attended the virtual Town and Community Council Liaison Joint meeting with the CCBC ClIrs on Wed 18 November. CCBC reported that the Welsh Government 2021/2022 annual financial settlements for the 22 Principal Councils had been delayed due to the health crisis, until 18 December. Thus any services provision CCBC were unable to provide would not be known until late December/early January. CCBC offered two virtual meetings with the Town and Communities in the next week of December to discuss their possible budget for 21/22

763.3 Correspondence/financial assistance applications

Cllr Mike Parker confirmed the alternative location for the community defibrillator is with staff at the Exchange Post Office

The Clerk reported that CCBC had removed some of their road works barriers on Tredegar Street for the Christmas shopping period The Council considered the recent receipt of a financial application from the Senior Citizens Hall Secretary for a further donation towards ongoing improvement works at the Hall. The Council agreed to support this application with a donation of £1500

The Clerk reported on an annual request from Llamau for childrens' Christmas presents and the Council agreed to support this charity with a donation of £100

764 Current Projects Summary

The Council were awaiting CCBC to relocate the recently removed eight street planters from Tredegar Street to be repositioned on the grassed area on Commercial Street at the Pontymister Roundabout. The Council agreed to purchase two new 4-tier planters for next summer and will continue to liaise with the local Scouts and Guides Groups for assistance, to tend to all the planters for next year
