803.1 Finance Report

The monthly account summary to date was agreed as satisfactory by the Council

803.2 One Voice Wales/CCBC/WG/SLCC/TCCLC

The Clerk and Cllr Sally Davies are to attend the One Voice Wales virtual Area Committee meeting on Wed 28 April. The Clerk reported that following the recent Town and Communities Joint Committee virtual meeting with CCBC Cllrs the CCBC Leader, Cllr Marsden, has said she will review the recent loss of overnight street lighting in the county borough. The Council were pleased to hear this report noting that several local residents had complained about the loss on public safety grounds

803.3 Correspondence/financial assistance applications

The Council considered a recent email application for finance from the Macmillan Charity and agreed for the Clerk to send the Council's donation of £200 to the charity in acknowledgement of their recent work during the health crisis. The Clerk reported that he is waiting for CCBC Parks to give a cost estimate for providing a new power supply at both memorial gardens, requested by Risca RBL. He also reported that Risca East had replied to him saying they will consider contributing to the overall cost when it is known and if it has funding available

The Council agreed to contribute £2000 to the Moriah Church's toilet block charity towards their maintenance costs providing the Charity can send a costings explanation to the Clerk for internal audit purposes. The Council is aware that the toilet block had been closed all year due to the current health crisis

The Council agreed for the Clerk to contact the County Cllrs, to check on the latest CCBC planning proposal for the buildings on the former Baths site at the Longbridge grounds

The Council agreed for the Clerk to write to CCBC in response to their 'Parklet' on-street proposals for 2021 to ensure their format is presentable and amenable for the Town and not in a 'road works style' as per 2020

804 Current Projects Summary

The Council is looking forward to taking on the 8 former CCBC flower planters in the Town alongside its flower baskets project for this summer. The Council agreed that whilst the health crisis was still with us they were unable to begin any planning for

their summer events. The Council will consider a new entertainments project over 2021/2022 to celebrate its tenth anniversary in April 2023
