G1 Finance Report

The Clerk reported that a monthly account summary to date was in a verbal format only due to the loss of a bank card and cardreader. The Chair reported that he had seen the up to date bank account statement online and the reports were agreed as satisfactory by the Council. The Clerk reported that he had submitted the 2020/2021 Audit Return with its back up papers to Audit Wales

G2 Correspondence/financial assistance applications

1/ The Council agreed to ask Caerphilly County Borough Council to provide a detailed cost estimate of an electrical supply to be located into both memorial gardens in the Town
