The Mayor added his regret at the storms' flooding and damage to properties in the Town

#### 1203 Clerk's Report 1203.1 Finance

The Clerk's monthly account summary was agreed as satisfactory by the Council. The Clerk re-presented a budget and precept report for 2025/26 for the Council to consider and decide upon. The Mayor suggested that to further improve upon this year's Winter Fair in 2025 an increase in the budget and precept was needed. The Council agreed a budget of £69,500 with a Band D household precept charge of £38 per year

## 1203.2 Correspondence/financial assistance applications

Following the recent storms and flooding in Risca Town, the Town Council raised the following question/request for CCBC: "Can CCBC provide us with details of when and how many times they cleaned the Town Centre drains over the last 3 years, please? The Town Council are aware that the Risca public are asking this same query

The Council agreed to make a donation of £200 to Llamau for Christmas Gifts. The Clerk is to advise Stephen Lyons from Blackvein Miners Society that his application will be considered in the spring when the Council's remaining funds are clear. The Clerk is to respond to the Risca Volunteers Group to say the Council is unable to contribute to its request for funding this year. The Clerk will also respond to Risca Male Choir turning down its request for an attendance fee of £250 for future community events. Cllr Mike Wedderien reported that the new Banking Hub were considering installing a cashpoint machine at the hub's building
