1228 Presentations - CCBC Officers Mark Goodger and Max Nebe gave the Council and visitors an update on the recent flooding issues in the Town following the recent storms. They added their CCBC plan for remedial action via a 'flood risk strategy' and seeking WG funding for priority treatment higher up the valley to hold storm water and improve the town centre's level drainage. Their 'action plan' includes clearing of drains 4 times a year and CCBC seeking a 'Working Flood Group' for Risca alongside other flood risk areas in the county borough. The Working Group suggestion is to be brought up by CCBC Officers at their next Risca Town Centre Management Group meeting set for Thursday 3 April with Risca stakeholders.
