1253 Clerk's Report

1253.1 Finance

The Clerk's monthly account summary was agreed as satisfactory by the Council. The Clerk reported that the Council laptop had failed over the weekend and they agreed for the Clerk to book it in for analysis and repair

1253.2 Correspondence/financial assistance applications

The Council considered a few recently raised complaints: concern that there is no lighting in the new Commercial Street car park for local business staff working into the darkness, drainage issues at the St Mary Street car wash establishment and that the removed footway boundary wall has not been replaced, weeds are not cut out from the local footways and some sandbags

are still not removed, The Council are aware that repair work has started at Stony Bridge and that CCBC are to resurface Maryland Street later this year. The Clerk is to notify the County Borough Ward Cllrs of these issues and items.

The Council considered the recent financial assistance request from Risca Senior Citizens Hall. The Council were aware that they had made previous donations to the Hall over the last few years and were unable to assist on this occasion. The Council also considered the recent financial assistance request from Risca Volunteers charity for vehicle maintenance costs. The Council decided that they were unable to contribute public money for vehicle maintenance. However, they agreed for the Clerk to submit the Council's assistance application forms to the applicant to see if the Council can assist the local charity on a community topic

CCBC had decided to cancel the 29 April TCCLC Joint meeting due to its pending decisions on both Libraries and Leisure Centres in the county borough.
