1323 Clerk’s Report

1323.1 Finance

The Clerk’s monthly account summary was agreed as satisfactory by the Council. The Clerk again presented four possible budgets/precepts for the Council to decide upon for 2026/2027. The Council is fully aware of the rising cost of living and increasing costs to maintain its projects and services to the Risca community and that Caerphilly county borough council asked for a financial contribution to its CCBC summer events. The Council is also aware that the Boundary Commission’s recommendation for Risca to be reunified, rather than being split into East and West Wards, is likely to take place at the Local Government Elections in May 2027. With all these facts in mind the Council decided on a budget of £94K for 2026/2027 with a Band D Council Tax

charge at Band D of £52 per household. The Clerk is to submit that decision to CCBC by 31 January in readiness for April 2026 to March 2027

1323.2 Correspondence/financial assistance applications

The Council agreed to a donation of £250 as financial assistance to Air Ambulance Wales. The Council considered the recent application from local business person Charlotte Evans for the Ty Isaf Fields Ward Member vacancy. The Council agreed for the Clerk to invite Charlotte along to its 12 January 2026 Council meeting to meet all the Town Cllrs

The next One Voice Wales Area Committee meeting is set for the new year via remote access. The spring TCCLC meeting is programmed for mid February 2026

The Council are awaiting details of an applicant for Risca Primary School's Governors' vacancy in order to be recommended to represent the Council

1324 Current Projects Summary

The Council are very pleased with the success of its Winter Fair and Christmas Tree lights switch on event on Saturday 22 November. The Council noted the excellent quality of the Town Council's marquee and the stage that were provided this year. It is also grateful for CCBC agreeing to allowing it to erect its 2025 Festive Lanterns project in time to coincide with the Winter Fair. The Council noted its concern at the time it took for the local contractor to obtain the CCBC required certificates and information for Christmas 2025. The Council are also aware of the recent compliments from residents and businesses in the Town's community about the quality of the Festive Lanterns
