The meeting was held with both in person and remote virtual availability on Monday 12 Jan 2026

The Clerk reported that he had received no requests to join virtually.

Chair/Mayor Cllr Mike Parker chaired the meeting that commenced at 6.35 pm

A/ Apologies and welcome – Apologies were received from Cllr Louise Stephens. The Chair welcomed Charlotte Evans who had applied for the Ward Member vacancy at Ty Isaf fields. G1 Finance Report

The Council noted that it had already given a commitment to contributing to the funding of a 'Big Screen' event planned for this summer by the Risca Cancer Charity group
